

The Government of Nepal [GoN] has allocated funds towards the cost of Mohanyal Gaupalika Stariya 10 Bed Adharbhut Hospital Building and intends to apply part of the funds to cover eligible payments under the Contract for Mohanyal Gaupalika Stariya 10 Bed Adharbhut Hospital Building (Contract No:MRM/WORKS/NCB/01/ 2077/78). Bidding is open to all eligible bidders as per Section V of Bidding Document
2. Mohanyal Rural Municipality, Kailali invites electronic bids from eligible bidders for the construction of CONSTRUCTION OF MOHANYAL GAUPALIKA STARIYA 10 BED ADARBHUT HOSPITAL BUILDING under National Competitive Bidding – Single Stage Two Envelope Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding:  
Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: 77000000  
Minimum Work experience of similar size and nature: AT LEAST ONE RCC BUILDING MINIMUM OF 80000000 ( EXCLUSIVE OF VAT )
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

Sealed or electronic bids must be submitted to the office Mohanyal Rural Municipality, Kailali, kailali district, Khimadi, 7 no Province, Mohanyal, Kailali, Sudoor Pachism Province, Nepal by hand/courier or through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 18-03-2021 12:00. Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at 18-03-2021 13:00 hours at the office of Mohanyal Rural Municipality, Kailali kailali district, phallibisauna-03 (Saparka Karyalaya)Mohanyal, Kailali, Sudoor Pachism ProvinceNepal. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 2800000/- which shall be valid for 30 days beyond the validity period of the bid.
